

Case Study: Determining excellence – pioneers of the GCSA global quality standard for clinical research sites in the Americas region.



Executive Summary

In September 2023, AGA Clinical Trials (AGA) became the first site organization in the Americas region to achieve GCSA Certification, with the GCSA Global Quality Standard for Clinical Research Sites being awarded across its sites in Ecuador and Miami, USA.

AGA's Drivers for GCSA Certification

Dedicated to being a global center of excellence and driven by their mission to improve health and quality of life for participants, AGA wanted to evidence to patients and sponsors that they were truly world-class. Operationally it was important for them to ensure streamlined and consistently high-quality service delivery across both their sites. Therefore, they engaged GCSA for assessment, gap analysis, and consulting support to achieve Certification.

About GCSA Certification

The GCSA Certification process was developed by IAOCR (the International Accrediting Organization for Clinical Research) in collaboration with global CROs, sponsors, regulators, and sites, over a five year period. It evaluates 7 business operations areas that are critical to the success of sites and clinical trials.

GCSA's independent assessment, gap analysis, process improvement, and Certification process, established consistency across both of AGA's sites. It identified several areas of operational excellence, where AGA exceeded the GCSA standard, as well as providing recommendations for further development.

Triple-Certified Lead Investigators

Committed to quality at both a site and workforce level, in addition to achieving GCSA Certification, AGA's two Lead Investigators also underwent rigorous assessment to achieve IAOCR Internationally Qualified Clinical Research Professional Accreditation (QM-IAOCR); building on their existing CCRP certifications awarded by SOCRA, and CPI certifications awarded by ACRP.

The GCSA Certification journey includes expert analysis of all documented processes, and conducting surveys, and discussions with site staff to ensure that processes and procedures are fully embedded. Feedback is confidential, yielding rich insights and ensuring that staff feel able to speak confidently and honestly. The independent assessment objectively reviewed and critiqued AGA's business operations processes. Following evaluation, insights and recommendations were shared to enable the basis for a continuous quality improvement journey.

About GCSA Site Certification And IAOCR Internationally Qualified Professional Accreditation



Awarded in over 55 countries, IAOCR
Accreditations (awarded to clinical research professionals) and GCSA Certification (awarded to site organizations) are based on robust and comprehensive assessment criteria developed with key industry stakeholders. Awards of Accreditation or Certification are made following rigorous evaluation of evidence by IAOCR qualified assessors and verifiers.

GCSA - The Global Quality Standard for Clinical Research Sites, is achieved through a journey of independent assessment, gap analysis, supported process improvement, prior to award of Certification. The GCSA process deep-dives into seven critical business process areas cited by sponsors, CROs and other key stakeholders as being significant to the success of clinical trials:

- · Patient Engagement
- Feasibility,
- Study Start-Up & Initiation
- Study Management Operations & Close-Down
- · Workforce Quality
- Site Business Strategy
- Governance

IAOCR Professional Accreditations carry internationally recognized Learning Credits and CPE Points (Continuing Professional Education Points). Assessment criteria is agreed with Global Industry Taskforce, prior to being mapped to international standards for qualifications and education to provide robust and globally valid professional standard.

The GCSA process also highlighted areas of excellence for AGA to leverage in business development and marketing activities as part of AGA's differentiated service offer.

QM-IAOCR

Through the independent assessment process, AGA Clinical Trials fully evidenced compliance with the GCSA global quality standard for clinical research sites.

Additionally, AGA Clinical Trials was found to be exceptionally strong in documented and embedded processes, communication, leadership clarity, operational consistency, and participant experience.

Feedback from GCSA Assessors

AGA demonstrated excellence in documented procedures and the workforce understanding of them, with robust systems ensuring trials run smoothly to timelines and budgets. Whilst AGA is a small organization, there were many clear processes in place. It was evident that the Clinical Trial Management System played an important part in ensuring all trials run effectively.

Effective cascading of trial requirements for each new trial, and **clearly defined roles** for each staff member involved, supports the overall goals and direction for clinical trial operations.

The participant experience is a key strength and consistently high-quality across both sites. Participant feedback is prioritized through a clear feedback loop. An opportunity was identified to strengthen this further by more directly incorporating participant input into service improvements and closing the loop by communicating changes back to participants.

AGA's business operations processes are consistent across both site locations. **Centralized operating procedures ensure consistency for clients and participants, providing high-quality trial delivery**, and a solid foundation for scalable growth.

KPIs drive ongoing development; enabling the company to evolve and commit to continual quality improvement, rather than rest on their success.

AGA's clinical trials intentionally address a wide range of ethnicities (Latino, African American, Asian and mixed-race), backgrounds, and conditions to better meet objectives and deliver meaningful results.

AGA's leadership team plays a vital role in the company's success. Clear roles and responsibilities ensure **streamlined operations** and ensure that **everyone works toward a unified vision**. Leadership communication is crucial for fostering a culture of collaboration and efficiency.
